## OPERATING RULES FOR THE CAMPSITES COLOURS OF OSTRAVA

### OPERATION OF CAMPSITES: CAMP SILESIAN OSTRAVA CASTLE, TENT INN CAMP, CHILL VILLAGE CAMP, AND ZTP CAMP

- Only visitors with a valid ticket to the Colours of Ostrava festival are allowed entry to the campsite.
- Festival participation conditions for Colours of Ostrava apply to all campsite visitors.
- Four campsites are available: Camp Silesian Ostrava Castle, Tent Inn Camp, Chill Village Camp, and Camp ZTP & ZTP/P.
- The campsites Silesian Ostrava Castle, Tent Inn, and Chill Village will be open from Tuesday, July 14 at 17:00 continuously until Sunday, July 19 at 15:00
- Visitors to the Chill Village and Tent Inn campsites can use toilets and hygiene facilities free of charge. Showers at the Silesian Ostrava Castle campsite are subject to a fee.
- Personal tent on-site – fee of 790 CZK per tent + 690 CZK per person in the tent.
- **THE ACCOMMODATION PRICE IS FIXED FOR THE ENTIRE DURATION OF THE CAMPSITE'S OPENING.**
- **CHILDREN UP TO 140 cm HAVE FREE ENTRY.**
- **ZTP AND ZTP/P HAVE FREE ENTRY** based on prior reservation.
- Visitors must present an ID card, passport, and a completed accommodation form upon entry.
- Visitors are fully responsible for their belongings placed in the campsite or tent.
- Storage lockers are available at the Camp Silesian Ostrava castle and at Důl Hlubina, in front of the festival area entrance.

### THE FOLLOWING ARE PROHIBITED FOR VISITORS:

- Lighting fires anywhere in the campsite.
- Smoking in tents or any fire-related activities.
- Entering through non-designated entrances (e.g., climbing over fences).
- Littering or any damage or threat to others' property or health.
- Disturbing nighttime peace:

**July 14: from 22:00 to 06:00**

**July 15: from 24:00 to 06:00**

**July 16: from 24:00 to 06:00**

**July 17: from 02:00 to 06:00**

**July 18: from 02:00 to 06:00**

### CAMP OVERSIGHT

- A security guard will monitor adherence to these rules.
- Individuals violating these rules may be removed from the premises or handed over to the Czech Police.
- Any infractions or criminal acts will be addressed by the Czech Police.
- In the event of a breach of rules or unforeseen events (force majeure such as natural disaster, criminal activity, terrorist attack, etc.), the organizer is authorized to take all necessary actions to protect persons and property and restore order (e.g., peace and security).
- The area may be evacuated if participants' health or organizer property is endangered (e.g., natural disaster, terrorist attack, etc.), without any compensation for damages or lost profits to any participant.

### PROCESSING OF PERSONAL DATA

- For the registration of accommodated participants, the organizer processes certain personal data as the data controller in accordance with Article 4(7) of Regulation (EU) 2016/679, the General Data Protection Regulation ("GDPR").
- Full details on personal data processing, including purposes, legal basis, data recipients, and participant rights as data subjects, are included in a separate annex to the visitor rules (Participation Terms for Colours of Ostrava 2026), available at [www.colours.cz](http://www.colours.cz) and on-site, including at the campsite entrances.
